Entrant Rules

BY SUBMITTING AN ENTRY TO CU*ANSWERS, YOU AGREE TO BE LEGALLY BOUND BY THE FOLLOWING TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS BELOW, DO NOT SUBMIT AN ENTRY TO CU*ANSWERS.

1. ELIGIBILITY: *Making Ownership Real* is only open to persons who are at least 18 years of age at the time of submitting an Entry who also belong to, are employed by, or purchase goods and services from a Cooperative organization; or organizations defined as a Cooperative organization in its local jurisdiction. Current CU*Answers' employees and their immediate families are not eligible to submit an Entry. Immediate family members include relatives living at the same address as an employee. Participation in *Making Ownership Real* is void where prohibited by law. All federal, state and local laws and regulations apply. *Making Ownership Real* will be construed and evaluated according to Michigan law.

2. ENTRY: A white paper entry ("Entry") to *Making Ownership Real* may be made or submitted by a person, a group of persons who all meet the Eligibility criteria above, or on behalf of a Cooperative organization.

3. ENTRY FEE: There is no entry fee to *Making Ownership Real*.

4. SPECIFIC RULES FOR ARTISTS REGARDING ENTRY: The following rules apply to submission of an Entry to *Making Ownership Real*:

- a. Eligible persons or organizations may submit more than one Entry. An Entry must list the name or names of the submitting persons or organizations, and a brief description of the person's affiliation with a Cooperative organization, or in the case of a Cooperative organization, a statement that the organization meets the definition of a Cooperative organization in the Cooperative's local jurisdiction.
- b. Minimum word count for each Entry is 800 words, not counting description of eligibility. There is no maximum restriction.
- c. To be eligible, an Entry must be uploaded in Adobe PDF or in a format openable and readable in Microsoft Word.
- d. An Entry must be submitted by 5:00 p.m. EDT on May 1, 2014.

e. Only original Entries are eligible for submission. Persons or organizations are responsible to ensure that the Entry does not infringe on any third party's proprietary rights.

f. CU*Answers reserves the right to use all information on, imagery and documentation pertaining to the Entry. CU*Answers may use the information, imagery and documentation described in the preceding sentence for the CU*Answers' website, press releases, promotional materials, catalogues, and associated events which may include textual, audio or visual representations. CU*Answers will acknowledge the person(s) or organization when such information, imagery and documentation is used by CU*Answers as described above.

g. CU*Answers bears no liability to participating persons or organization, or relating to the Entry.

The Prize will be awarded in a lump sum to the individual person or persons, or collaborative organization in whose name the Entry was submitted. For multiple person entries, the Prize will be divided up among the names listed on the Entry submission.

9. TRANSFER OF WINNING ENTRY TO CU*ANSWERS: Winners agree to transfer all rights and ownership of the winning Entry to CU*Answers. Winners agree these transferred rights include all underlying copyrights in and to the Entry, including the specific authority to make derivative works relating to the Entry.

10. WINNERS' NAMES: Names of winners will be available on the CU*Answers website or upon request.

11. GENERAL CONDITIONS: Winners will be required to sign and return a Winner's Affidavit of Eligibility and Release Form. In the event of noncompliance, the prize will be forfeited and may be awarded to an alternate winner. All federal, state and local taxes are the sole responsibility of the winner.
